## NEW RIVER CTC WELDERS FEATURED ON BARNWOOD BUILDERS

A new season of Barnwood Builders will premiere next Tuesday, Oct. 7, at 10 p.m. on the Great American Country network. The series features Greenbrier County's own Mark Bowe and his team of craftsmen who are passionate about salvaging old barn wood and using old-world craftsmanship to re-purpose it. According to the show's publicist, "They are masters of big, filthy, difficult, 19th-century restorations, and they are as entertaining as a woodpecker in a lumber yard."

One of the projects the team tackled this season was transforming a standard shipping container into a tiny log cabin by overlaying it with barn wood. In order to make the transformation, they needed to cut windows in the metal and also take the metal roof off the container so that a sloped roof could be constructed. They needed welders, and New River CTC had students with the skills to get the job done.

Brad Veneri, welding instructor at the Advanced Technology Center recruited students Thomas Legg (above left) from the Greenbrier Valley Campus and Zach Amon (above right) from the ATC to assist with the project. In July, they spent several

very warm days in front of the cameras at Bowe's business, Antique Cabins and Barns, located on Route 92 north of White Sulphur Springs.

## Reminders from the Finance Office

- A travel authorization is needed for all overnight travel and requires pre-approval by the budget manager
  and the President of the College. This needs to be submitted 30 days prior to the actual travel.
- All association dues and professional membership involving payment of dues require pre-approval by the budget manager and the CFO.
- Prior to a purchase of more than \$1,000, a Purchase Request Form with departmental, major administrator and the CFO's approval is required.
- Hospitality-related expenses exceeding \$500 require pre-approval by the CFO. A sign-in list of all attendees at an event funded by hospitality is required.
- All contracts and professional service agreements require the approval of the CFO prior to any work
  performed for the College. The President and the CFO are the only employees of the College permitted
  to authorize money to be encumbered.

Dr. Christopher Linsin, instructor of history, pitched the project to his classes, and three students eagerly accepted the challenge. Jennifer Miller, Deny Doss and Samantha May all want to become teachers, and working on the exhibit was an excellent opportunity to explore a fascinating aspect of local history.



The exhibit consists of a collection of photographs and artifacts, from post-civil war to today, of African Americans who have contributed to the growth and development of this area in business, religion, education, sports, politics, and entertainment as well as general family life. It highlights a few individuals who were born and raised in Greenbrier County, left the area and are making significant impact in various areas, such as the U.S. Government and the arts.

"We will be developing an ongoing association with the Greenbrier Historical Society and Ms. Cooley in the future. This project is just the beginning," Linsin said.
