SCOPE

This policy applies to all members of the New River Community and Technical College community, including faculty, staff and students, as well as visitors to any campus.

Compliance – Legislative Rule

West Virginia Code §61-7-14, Right of certain persons to limit possession of firearms on premises.

POLICY STATEMENT

New River Community and Technical College has a responsibility to provide a safe and secure environment for its employees and students. In support of this responsibility, the College has established the following rule regarding firearms, weapons, and explosives on its property.

PURPOSE

The purpose of this policy is to impose the prohibition of a penalty for the possession or storage of firearms, weapons, and explosives in any form on the premises of New River Community and Technical College.

GENERAL PROVISIONS

Any student, faculty or staff member violating this policy shall be subject to the disciplinary policies and procedures applicable to students, faculty or staff, including but not limited to suspension, expulsion, termination of employment, immediate removal/trespass from the premises, in addition to the penalties provided under State law.

TERMS AND DEFINITIONS

TERM	DEFINITION
Firearm	Any device that shoots a bullet, pellet, flare, tranquilizer, spear dart, paintball or other projectile, whether loaded or unloaded, including those powered by CO2. This includes, but is not limited to, guns, air guns, dart guns, pistols, revolvers, rifles, cannons, etc., and any ammunition for any such device.
Weapon	Any device that is designed to or traditionally used to inflict harm. This includes, but is not limited to: <ol style="list-style-type: none"> 1. Firearms, slingshots, switchblades, daggers, blackjacks, brass knuckles, bows and arrows, hand grenades, hunting knives, nun-chucks, throwing stars, etc.; 2. Any object that could be reasonably construed as a weapon; or 3. Any object legally controlled as a weapon or treated as a weapon under the laws of the State of West Virginia.

Explosives

Any chemical compounds or mechanical mixture that contains any oxidizing and combustible units, or other ingredients, in such proportion, quantities or packing that an ignition by fire, friction, concussion, percussion, or detonator, or any part of the compound or mixture, may cause a sudden generation of highly heated gases that result in gaseous pressures capable of producing destructive efforts on contiguous objects or of destroying life or limb. This includes, but is not limited to, firecrackers, black powder, dynamite, etc., as well as detonating devices such as detonators, blasting caps, timers, incendiary wire and the like.

SECTION 1: POLICY

It is prohibited to possess firearms, weapons, and/or explosives on New River Community and Technical College campuses, or any College-leased facilities, in College vehicles, on any real property under the care, custody, and control of the College, or at any College-sponsored event without the explicit authorization of the President, whether or not it is done openly or concealed and whether or not a federal or state license to possess the same has been issued to the possessor. The only exceptions to this policy are as follows:

1. Law enforcement officer to the extent they are legally permitted to possess weapons pursuant to West Virginia State Law;
2. Military personnel in performance of their official duties to the extent they are legally permitted to possess weapons in the State of West Virginia; and
3. College sanctioned classes, group or events where a particular weapon(s) is required and regularly used as part of the curriculum or activity, i.e., various Criminal Justice courses. The control, security and safe use of such weapons shall be the responsibility of the supervising faculty member. The supervising faculty member shall inform the appropriate Director of Facilities and Campus Safety in advance of any unusual or seldom occurring events involving the use of weapons on campus.
4. Any person carrying or possessing a firearm or other deadly weapon in violation of this policy who, upon being requested to do so, refuses to temporarily relinquish possession of the firearm or other deadly weapon, and/or refuses to leave the College premises or grounds as previously defined while in possession of the firearm or deadly weapon, shall be charged with a misdemeanor, and upon conviction thereof, can result in a fine of up to \$1,000, or up to six months in jail, or both (§61-7-14 WV Code).

EXCEPTIONS/EXCLUSIONS

Exceptions to this policy may be requested in writing to the President. Only under very limited circumstances will an exception be granted. Questions regarding the applicability of this policy to specific items must be directed to the President.

REVIEW

This policy shall be reviewed on a regular basis with a time frame for review to be determined by the President or the President's designee. Upon such review, the President or President's designee may recommend that the policy be amended or repealed.
